This policy is reviewed and updated annually to ensure that non-examination assessment at The Portsmouth Academy are planned for and managed in accordance with current requirements and regulations.

References in this policy to NEA and ICC refer to the JCQ documents **Instructions for conducting non-examination assessments** and **Instructions for conducting coursework**.

Introduction

Non-examination assessments measure subject-specific knowledge and skills that cannot be tested by timed written papers.

There are three assessment stages and rules which apply to each stage. These rules often vary across subjects. The stages are:

- task setting
- task taking
- task marking (NEA 1)The regulator's definition of an examination is very narrow. In effect, any type of assessment that is not 'externally set and taken by candidates at the same time under controlled conditions' is classified as non-examination assessment (NEA).

'NEA' therefore includes, but is not limited to, internal assessment. Externally marked and/or externally set practical examinations taken at different times across centres are classified as 'NEA'. (NEA, Foreword).

Coursework components assess candidates' skills, knowledge and understanding that may not readily be assessed by timed written papers. Coursework will take many different forms. (ICC 1)

The term coursework is a generic one. It includes the work required in Project qualifications and internally assessed work in other qualifications covered by these Instructions. The instructions are for use in AQA Applied General qualifications, OCR Cambridge Nationals, CCL GC united AS and A-level qualifications, ELC and Project qualifications. They may also apply to other awardir ody-spector Lovel 1, Level 2 or Level 3 qualifications. Centres should refer to awarding body instructions. They may also apply to other awardir ody-spector Lovel 1, Level 2 or Level 3 qualifications.
